RED

Limited to 100 people with no distancing requirements

Limited to 25 people with no distancing requirements

**Other gatherings**  
Limited to 25 people, based on 1m capacity distancing

**Events**  
Cannot operate

Workplaces open (i.e. church offices)

Face masks required for workers (paid and voluntary), and encouraged for others if you have exclusive use of the gathering space.

Face masks required for everyone if you do not have exclusive use of the gathering space.

GENERAL

**Gatherings** include any gatherings, either worship or social, that are associated with the church. This would include Sunday services, home groups, youth group, and children's groups. These can be in homes, indoors at church, or at any outdoor space such as parks.

**Events** are indoor and outdoor organised activities that have controlled access of customers or clients via ticketing, registration, fees on-site, or other controllable entry.

**Food and drink** can be served at any gathering with no hospitality rules applied.

**Children** are included in the capacity limits. Children under 12 years and 3 months without a My Vaccine Pass can enter gatherings where My Vaccine Passes are required.

**Capacity** - People do not need to stay 1 metre apart but there must be capacity for them to do so within the space.

**Workers (paid and voluntary)** are not included in the capacity limits.

**Multiple gatherings** can be held at the same location with My Vaccine Pass declared groups and no My Vaccine Pass declared groups. To do so there shouldn't be any mixing of groups, spaces are well-ventilated, and high use surfaces are cleaned.

**Covid Tracer App** - Record keeping/scanning is required at all times.

**At My Vaccine Pass declared gatherings**, My Vaccine Passes must be sighted for all attendees and workers including volunteers.

**Events at orange and red** - My Vaccine Passes must be sighted for all attendees and workers including volunteers.
